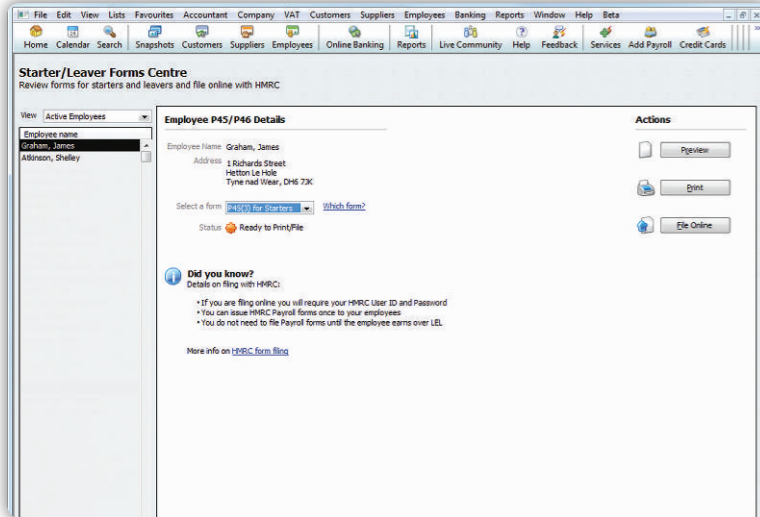


## HMRC accredited

### Getting started

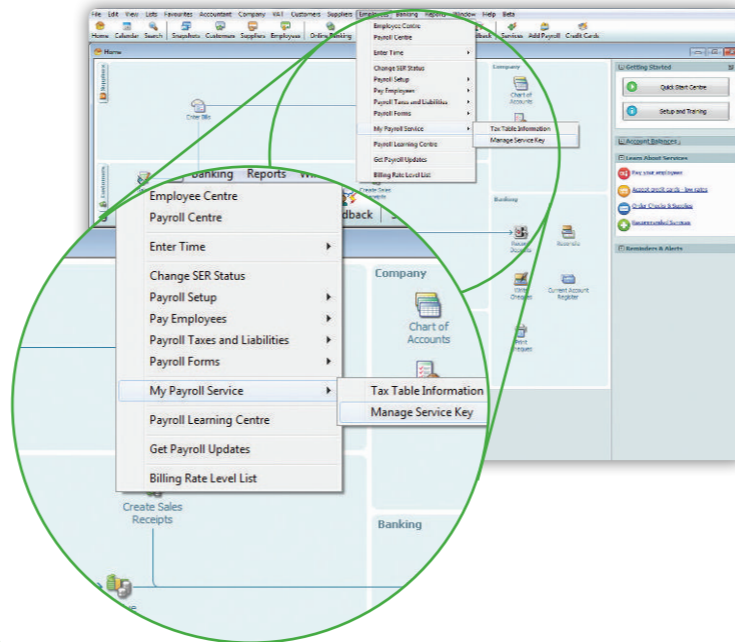
Payroll activation is a one-time process that unlocks the Payroll features in your QuickBooks software.

#### 1 Activate your Payroll subscription\*

1. Install your QuickBooks package by following the simple instructions on the inside cover of your product box.
2. With your License Key to hand, call Intuit on **0808 168 9535** and ask a Customer Service Agent to activate your QuickBooks Payroll. (8am to 8pm, Monday to Friday, including Bank Holidays.)<sup>‡</sup>
3. The Customer Service Agent will provide you with a Service Key to unlock the Payroll service features.

#### 2 Enter your Payroll Service Key in QuickBooks

1. Within QuickBooks, select the **Employees** drop-down menu, go to **My Payroll Service**, and select **Manage Service Key**.
2. In the **Service Key** field, enter your Payroll service key and then click Next.
3. Click **Finish**. QuickBooks Payroll is now activated.



#### 3 Now get set up and start paying your employees

1. Choose the employees you wish to pay and enter the hours they worked.
2. Check and approve the QuickBooks summary of pay.
3. Print or email your automatically generated payslips.
